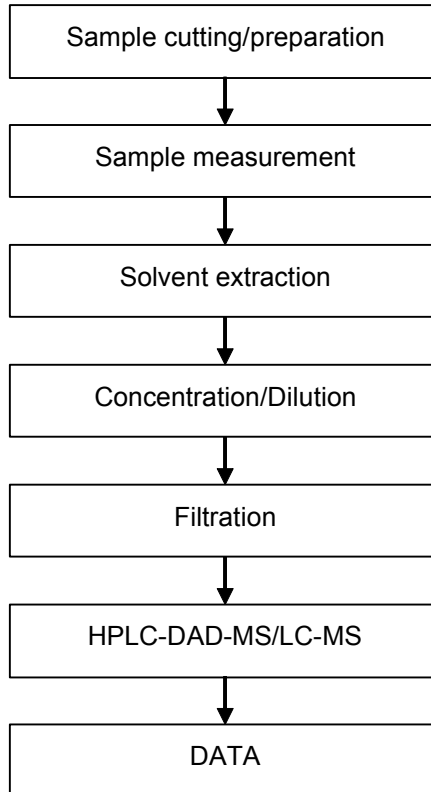

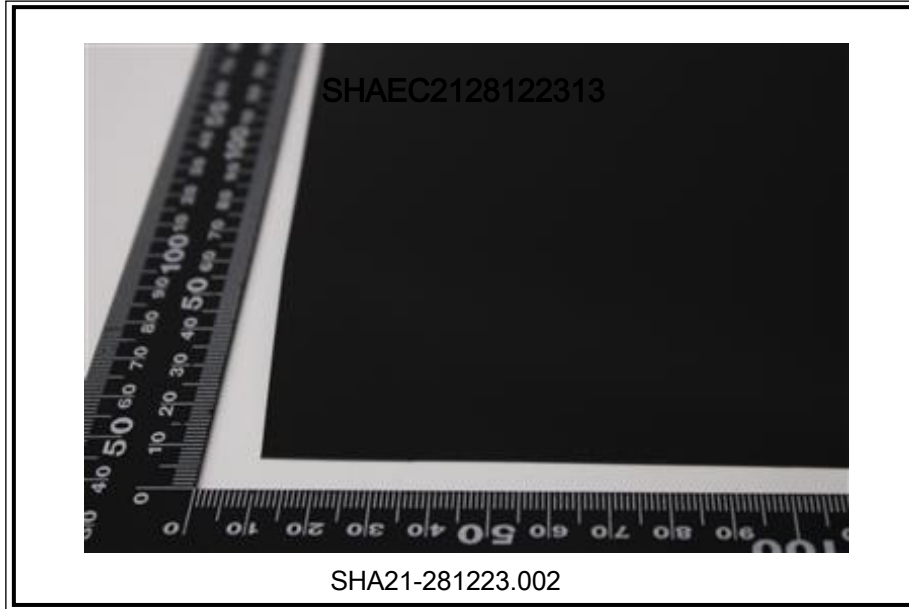
**BPA Testing Flow Chart**
